4. First-aid measures

Methods and materials for containment and cleaning up

Refer to attached safety data sheets and/or instructions for use. Do not clean up or dispose of except under supervision of a specialist. Stop leak if you can do so without risk. ELIMINATE all ignition sources (no smoking, flares, sparks or flames in immediate area). Avoid dust formation. This product is miscible in water. This material is classified as a water pollutant under the Clear Water Act and should be prevented from contaminating soil or from entering sewage and drainage systems which lead to waterways. Should not be released into the environment. Clean up in accordance with all applicable regulations.
